## **Electrical installation**


A Actuators with appliance cables are numbered.

 $\bigwedge$  Provide overload protection and disconnect as required.


Actuators may be connected in parallel if not mechanically linked. Power consumption and input impedance must be observed.

#### Wiring diagrams






Floating Point AC 100...240 V
