


Product features










\ Actuators may also be powered by 24 VDC.

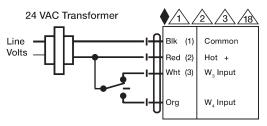
Actuators Hot wire must be connected to the control board common. Only connect common to neg. (-) leg of control circuits. Terminal models (-T) have no-feedback.

One built-in auxiliary switch (1x SPDT), for end position indication, interlock control, fan startup, etc.

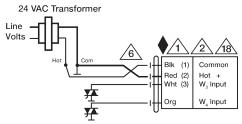

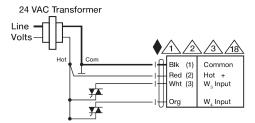

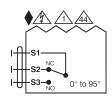
Floating Point
