





Actuators may be powered in parallel. Power consumption must be observed.

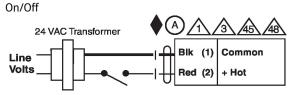
Parallel wiring required for piggy-back applications.
