INSTALLATION NOTES

- Actuators with appliance cables are numbered.
- Universal Power Supply (UP) models can be supplied with 24 VAC up to 240 VAC, or 24 VDC up to 125 VDC.
- Provide overload protection and disconnect as required.
- Actuators may be powered in parallel. Power consumption must be observed.

Parallel wiring required for piggy-back applications.

Meets cULus requirements without the need of an electrical ground connection.
