- ⚠ 1 Provide overload protection and disconnect as required.
- ⚠ 2 Actuators may be connected in parallel. Power consumption and input impedance must be observed.
- ⚠ 3 Actuators may also be powered by 24 VDC.
- ⚠ 5 Only connect common to negative (-) leg of control circuits.
- ⚠ 7 A 500 Ω resistor (ZG-R01) converts the 4...20 mA control signal to 2...10 V.
- ⚠ 16 Actuators are provided with a numbered screw terminal strip instead of a cable.
- ◆ Meets cULus requirements without the need of an electrical ground connection.
