


## Flow/Mounting details

UP Universal Power Supply (UP) models can be supplied with 24 VAC up to 240 VAC, or 24 VDC up to 125 VDC.
Apply only AC line voltage or only UL-Class 2 voltage to the terminals of auxiliary switches. Mixed or combined operation of line voltage/safety extra low voltage is not allowed.




