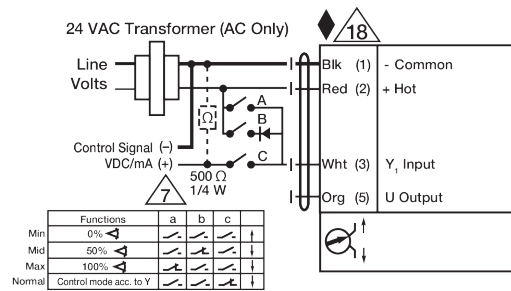
**✂️ INSTALLATION NOTES**

- ⚠️ 2 Actuators may be connected in parallel. Power consumption and input impedance must be observed.
- ⚠️ 3 Actuators may also be powered by 24 VDC.
- ⚠️ 7 A 500 Ω resistor (ZG-R01) converts the 4...20 mA control signal to 2...10 V.
- ⚠️ 8 Control signal may be pulsed from either the Hot (Source) or Common (Sink) 24 V line.
- ⚠️ 9 For triac sink the common connection from the actuator must be connected to the hot connection of the controller. Contact closures A & B also can be triacs. A & B should both be closed for the triac source and open for triac sink.
- ⚠️ 18 Actuators with plenum cable do not have numbers; use color codes instead.
- ◆ Meets cULus requirements without the need of an electrical ground connection.
